BRENDA WILBUR – WA4128295: Voter Challenge Summary

Background

Registered voter BRENDA WILBUR, DOB 14 June 1960, (the "VOTER") is registered with a residence address of 4417 LANDMARK DRIVE, MOUNT VERNON WA 98274 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O. Box 1513, Mount Vernon 98273.

History

The Washington Voter Research Project canvassed this address on 19 May 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 19 May 2024, an affidavit was collected from affiant LANCE GAINES certifying that the VOTER does not reside at the address.

Letter(s)

On 20 May 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form. A copy of the letter was mailed to the separate address in the VRDB.

Envelope

On or about 14 June 2024, the letter to the residence address in the VRDB was returned to me marked "Return To Sender – Unclaimed – Unable to Forward".

A Skagit County Property Search conducted on 17 June 2024 shows that there is no real property in Skagit County owned in the name Brenda Wilbur.

Source 4: Washington State Secretary of State <https://voter.votewa.gov/>

As of 1 June 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Brenda Wilbur with a birthyear of 1960 with a residence address of 4417 Landmark Drive, Mount Vernon WA last voted on 8 November 2022.

The Idaho Voter Roll as at 20 June 2024, containing the voter registrations of all voters registered in the state, returns a voter registered in the name Brenda Elaine Wilbur, however with an age inconsistent with the age of the VOTER as set out in the VRDB.

As of 17 June 2024, the Skagit County Jail Roster search shows no current inmates with the name of Brenda Wilbur.

As of 17 June 2024, the Washington Department of Corrections search shows no current incarceration for anyone named Brenda Wilbur.

Source 8: Federal Bureau of Prisons

As of 17 June 2024, the Federal Bureau of Prisons Inmate Locator shows no current federal incarceration for anyone named Brenda Wilbur. It appears a Brenda Wilbur with an age consistent with the VRDB is in the BOP system having a formal BOP number, perhaps associated with a prior federal criminal matter.

Conclusion

An affidavit was obtained attesting that BRENDA WILBUR does not currently reside at 4417 LANDMARK DRIVE, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers with a 360-area code, and is not registered to vote in Idaho. The letter to the voter posted to the residence address was returned marked "Return To Sender – Unclaimed - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

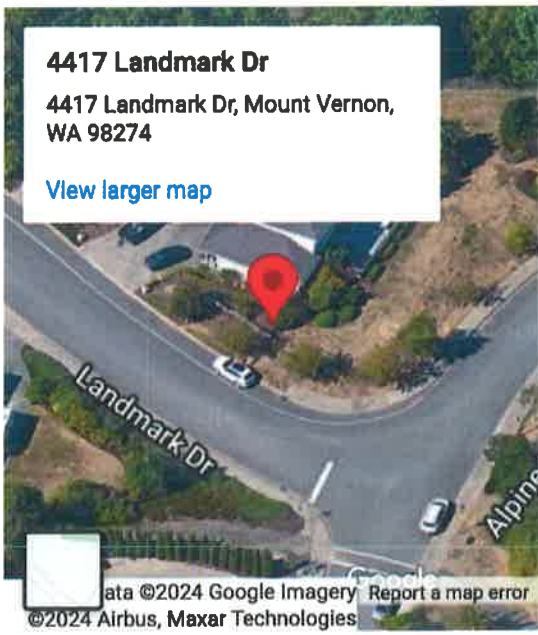

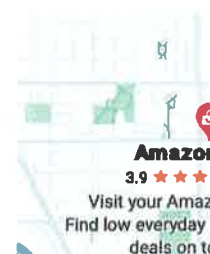
