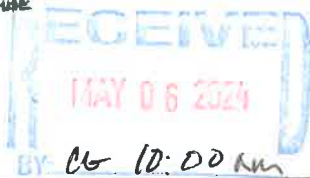

KARLA WILLETT – WA1772023: Voter Challenge Summary

Background

Registered voter KARLA WILLETT, DOB 12 January 1974, (the “VOTER”) is registered with a residence address of 2511 RIVER VISTA PL UNIT B, MOUNT VERNON WA 98273 and a status of Active. There is no separate mailing address on file for the VOTER in the Voter Registration Database (“VRDB”).

History

The Washington Voter Research Project canvassed this address on 3 February 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 3 February 2024, an affidavit was collected from affiant ROY KENNETH FENTRESS, certifying that the VOTER does not reside at the address.

Letter

On 6 February 2024, I mailed a letter via USPS Certified Mail to the address on file in the VRDB, notifying the VOTER that the residence address listed in the VRDB is incorrect. The letter encouraged the VOTER to update their voter registration, provided several different ways the VOTER could do so, and included an official Washington State Voter Registration Form.

Envelope

On or about 12 February 2024, the letter to the residence address in the VRDB was returned to me marked “Return To Sender – Insufficient Address – Unable to Forward”.

Data obtained from this source on 25 April 2024 shows a Karla Willett with an age consistent with the birthdate listed in the VRDB at the address of 3011 Northwest Ave, Bellingham WA 98225. There are (or were) two (2) *landline* phone number with a 360-area code, a code incorporating Skagit County.

A Skagit County Property Search conducted on 25 April 2024 shows that there is no real property in Skagit County owned in the name Karla Willett.

As of 1 April 2024, the Washington State Secretary of State website (containing voter registration data of Washington State registered voters) shows Karla Willett with a birthyear of 1974 with a residence address of 2511 River Vista PI Unit B, Mount Vernon WA last voted on 3 November 2020.



Conclusion

An affidavit was obtained attesting that KARLA WILLETT does not currently reside at 2511 RIVER VISTA PL UNIT B, MOUNT VERNON WA. The data indicates that the voter does not own property in Skagit County, has (or had) *landline* phone numbers in Skagit County, and is not registered to vote in the 30+ states covered by VoteRef. The letter to the voter posted to the residence address was returned marked "Return To Sender – Insufficient Address - Unable to Forward".

This voter meets the requirements for a successful voter challenge under RCW 29A.08.810. It is therefore respectfully requested the voter be removed forthwith from the roll or the government show good cause in writing why the voter may not be so removed.

(A) Sent a letter with return service requested to the challenged voter's residential address provided, and to the challenged voter's mailing address, if provided;

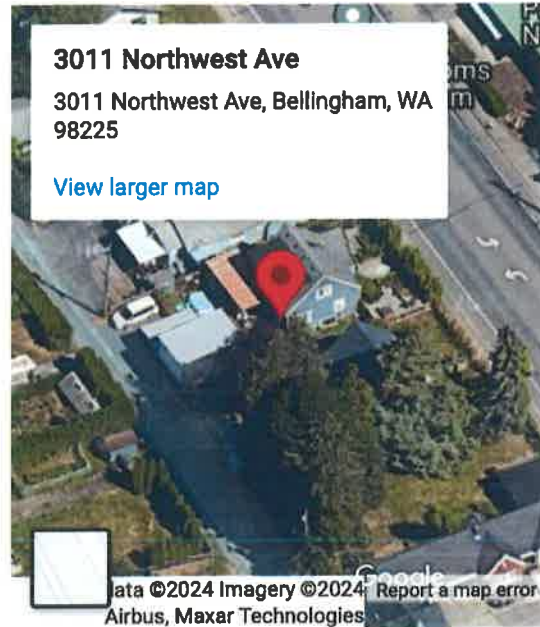

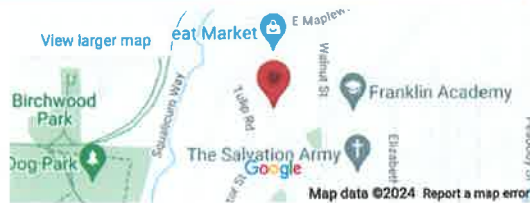
