Background

Registered voter ANGELA KAREN YAHNKEE, DOB 27 September 1967, (the "VOTER") is registered with a residence address of 1329 EAGLE RIDGE DR, MOUNT VERNON WA 98274 and a status of Active. There is a separate mailing address on file for the VOTER in the Voter Registration Database ("VRDB") of P.O. Box 2631, Mount Vernon WA 98273.

History

The Washington Voter Research Project canvassed this address on 22 April 2024. At the time, the canvasser learned the VOTER did not reside at the residence address listed in the VRDB.

Affidavit

On 22 April 2024, an affidavit was collected from affiant JOYCE GALBREATH, certifying that the VOTER does not reside at the address.

Conclusion




