Introduction

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., querying online databases as required) and via others (e.g., tracking letters handled by USPS).

This Challenge is not based upon unsupported allegations or allegations of anonymous third parties.

It is noted hearsay evidence is admissible in support of this Challenge. (Ref. RCW34.05).

Having exercised due diligence to personally verify the evidence presented on information and belief, following is the factual basis for the Challenge:

Background

Registrant TIMOTHY DANIEL BELFIELD, YOB 1962 (the “REGISTRANT”), is registered with a residence address of 53613 SHULAR RD, ROCKPORT 98283. There is a separate mailing address on file for the REGISTRANT in the Voter Registration Database (“VRDB”) of P.O. Box 1677 Anacortes WA 98221.

The REGISTRANT disposed of and transferred the registered address to a third party in 2024 and no longer resides there. The REGISTRANT provided a Declaration sworn under penalty of perjury (in connection with a court dispute with his former neighbor in Rockport) that he no longer resides at the registered address (see, ¶8). The registered address is therefore no longer his actual domicile and permanent residence.

Letter

On 30 March 2026, a letter was sent via USPS Certified Mail to the address on file in the VRDB, notifying the REGISTRANT that the residence address listed in the VRDB is incorrect. The letter encouraged the REGISTRANT to update his registration with his correct residence address and included an official Washington State form. A copy of the letter was mailed to the separate mailing address.

I, Tim Belfield, declare and say:

1. I am over the age of 18 and competent to be a witness and base this declaration on my personal knowledge. I have personal knowledge of the facts set forth below and am competent to testify to the same.
2. I am the previous owner of the real property commonly referred to as 53613 Shular Road, Rockport, Skagit County, Washington, APN P44690 & P118289. This is the real property now owned by Plaintiff Winters in this action (the "Winters Property").
3. The Winters Property borders the real property owned by Defendant Anthony Romano, commonly referred to as 53553 Shular Road, Rockport, Skagit County, Washington (the "Romano Property").
4. I was previously involved in an action against Defendant Mr. Romano in Skagit County Superior Court, SCSC Case No. 21-2-00585-29, concerning Defendant's conduct toward my wife and me and Mr. Romano's claims of easement and water rights affecting our property.

DECLARATION OF TIM BELFIELD (1)

- 1 5. On August 22, 2024, the Skagit County Superior Court entered an Order Granting
2 Plaintiffs' Motion for Summary Judgment in that action (Dkt. 57) Among other things,
3 the Court determined that Defendant had no easement or water rights across our property
4 and entered injunctive relief restricting Defendant's conduct.
- 5 6. As part of the above-referenced Order, Defendant Anthony Romano was expressly
6 forbidden from harassing the Belfields **or any potential buyer of that property**,
7 including coming within twenty-five feet of them or posting signs in and around the
8 property. See Order attached hereto as **Exhibit "A"**.
- 9 7. When the Order was entered, my wife and I intended to sell the property (now referenced
10 as the "Winters Property" in this action). The Court's inclusion of "any potential buyer,"
11 as referenced in paragraph 22 of Plaintiffs' Complaint, was important to us not only
12 because Defendant's conduct would interfere with our ability to sell the property, but also
13 because we did not (and still do not) want future (and now, current) owners of the
14 property to endure the harassment we experienced from Mr. Romano.
- 15 8. Plaintiffs in this action were purchasers of our former property and were plainly within
16 the category of "potential buyers" referenced in the Court's August 22, 2024, Order.
- 17 9. It was my understanding at the time the Order was entered that the restriction against
18 harassing "any potential buyer" was intended to protect people like the Winters from
19 being subjected to the same conduct by Defendant that my wife and I experienced.
- 20 10. I fully support and endorse the position that the Winters should receive the benefit of the
21 Court's prior Order and that Defendant is in contempt of that Order, as it was my belief
22 that the Order was intended to prevent Defendant from harassing individuals who
23 purchased our former property.
- 24 11. If the Court does not find that this Order protects the Winters, I fully support and will
25 testify as to harassment I suffered from as a result of Romano's conduct and my
26 knowledge regarding the ongoing harassment that is occurring to the Winters in order to
27 establish that a new Order should be issued for their protection and to stop the continued
28 trespassing.
