TRACT "A"

That portion of Tracts 16 and 17, Plat of Cheasty's Big Lake Tracts, as per plat recorded in Volume 4 of Plats, Page 49, records of Skagit County, Washington, more particularly described as follows:

Beginning at the Northwest corner of said Tract 16; thence South 33°00'15" East along the Southwesterly line of said Tracts 16 and 17 a distance of 102.04 feet; thence North 67°04'33" East a distance of 86.33 feet; thence North 33°00'15" West parallel with the Southwesterly line of said Tracts 16 and 17 a distance of 112.61 feet to the Northwesterly line of said Tract 16; thence South 60°03'33" West a distance of 85.12 feet to the TRUE POINT OF BEGINNING.

TRACT "B"

Beginning at the Northeast corner of said Tract 19; thence South 58°02'38" West along the Northwesterly line of said Tract 19 a distance of 20.00 feet; thence South 31°18'42" East parallel with the Northeasterly line of said Tract 19 a distance of 80.00 feet; thence South 58°02'38" West a distance of 93.08 feet; thence South 33°00'15" East a distance of 55.85 feet; thence South 86°00'00" East a distance of 47.19 feet; thence North 59°11'57" East a distance of 72.93 feet to the Northeasterly line of said Tract 23; thence North 31°18'42" West along the Northeasterly line of said Tract 23 and said Tract 19 a distance of 165.03 feet to the TRUE POINT OF BEGINNING.

Beginning at the Southwest corner of said Tract 17; thence North 33°00'15" West along the Southwesterly line of said Tract 17 a distance of 20.31 feet; thence North 67°04'33" East parallel with the Southeasterly line of said Tract 17 a distance of 167.02 feet; thence South 86°00'00" East a distance of 47.19 feet; thence North 59°11'57" East a distance of 72.93 feet to the Northeasterly line of said Tract 23; thence South 31°18'42" East along said Northeasterly line a distance of 101.80 feet; thence South 66°24'25" West a distance of 184.79 feet to the Northeasterly line of an unnamed 16 foot wide alley; thence along the Northeasterly margin of said alley, North 34°25'11" West a distance of 96.16 feet to the Southeasterly corner of said Tract 17; thence South 67°04'33" West a distance of 88.68 feet to the TRUE POINT OF BEGINNING.
