In Section 26, Township 36 North, Range 2 East W.M.;

All that portion of unused county road right-of-way which was deeded for the Harold R. Roney Road #295 and never used or a road never constructed and which begins at the terminus of the existing Harold R. Roney Road #3061, a county road, thence continues westerly for approximately 880 feet, more or less; said right-of-way to be vacated 30 feet in width.

**ORDER VACATING COUNTY ROAD**

In the Matter of the request by  
**THE BOARD OF SKAGIT COUNTY COMMISSIONERS**

For the vacation of a portion of County Road/Right-of-Way known as:  
**THE HAROLD R. RONEY ROAD #295**

In the matter of the vacation of a County Road right-of-way requested by  
the Skagit County Commissioners, the Board finds as follows:

**FIRST.** That the request therefor was filed on the 1st day of April,  
1991,.....and.....

**SECOND.** That.....

**THIRD.** That on the 22nd day of April, 1991, the County Engineer was duly  
directed to examine said road and make a report in writing on the same.

**FOURTH.** That on the 22nd day of April, 1991, the County Engineer filed  
in the office of the Board his report in writing.....  
....., as provided by law.

**FIFTH.** That by an order duly passed by this Board on the 22nd day of  
April, 1991, the 13th day of May, 1991, was set for hearing the report of the  
Engineer, and the consideration thereof, and that notice of the time and place  
where said hearing would be held was given by publication and posting as provided  
by law.

**SIXTH.** That said report of the County Engineer shows:

That in his opinion said right-of-way should be vacated.

That said right-of-way is not in use.

That it will not be advisable to preserve the same for  
a general road system in the future.

That the public will be benefitted by its vacation.

That:

the public hearing scheduled for April 29, 1991 by Resolution #12,929 was rescheduled to May 13, 1991 so the legal description could be revised to include additional right-of-way abutting along the Margaret Dunnington parcel per her request and;

the Board having examined the report of the Engineer, and all other papers on file in the proceedings, and heard and considered all testimony and documentary evidence produced for and against the vacation of the right-of-way, and the Board being satisfied that said right-of-way will not be useful as a part of a general road system, and that the public will be benefitted by its vacation, did unanimously vote to vacate said right-of-way described as follows:

In Section 26, Township 36 North, Range 2 East W.M.;

All that portion of unused county road right-of-way which was deeded for the Harold R. Roney Road #295 and never used or a road never constructed and which begins at the terminus of the existing Harold R. Roney Road #3061, a county road, thence continues westerly for approximately 880 feet, more or less; said right-of-way to be vacated 30 feet in width.

Less franchises and easements of record.

It is Ordered by the Board, all the members concurring, that the county road requested to be vacated by the Board of County Commissioners be vacated.
