EASEMENT

THIS AGREEMENT made this 25th day of May , 1999, by and between SKAGIT COUNTY SEWER DISTRICT NO. 2, a municipal corporation of Skagit County, Washington, hereinafter termed "Grantee" and Clarence M. and Lona C. Vander Griend, hereinafter termed "Grantor".

WITNESSETH:

That the said Grantor for valuable consideration does by these presents grant unto the Grantee a perpetual right-of-way or easement for sewer mains with the necessary appurtenances through, over and across the following described property situated in Skagit County, Washington, more particularly described as follows:

Lots 1, 2, 3, except the Northwesterly 30 feet thereof, Block 41 "Plat of the Town of Montborne", according to Plat recorded in Volume 2 of Plats,

page 80, records of Skagit County, Washington, except the Northeasterly 40 feet of said premises conveyed to Skagit County by Deed dated October 9, 1946 and recorded October 15, 1946, under Auditors File No. 397033 in Volume 213 of Deeds, page 368. Together with that portion of vacated Lakeside Boulevard and Lafayette Street adjoining said premises.

This easement is that portion of the above described lots included within the limits of a strip of land ten (10) feet in width, the centerline of which is described as the centerline of the sewer mains as constructed.

TOGETHER WITH: the right of ingress and egress along existing gravel roadway/pathway (or as may be improved or modified in the future) leading to existing Lift Station #3 from West View Road.

That said Grantee shall have the right without prior institution of any suit or proceeding at law, at such times as may be necessary, to enter upon said property for the purpose of constructing, repairing, altering, or reconstructing said sewer main, or making any connections therewith, without incurring any legal obligation or liability therefor; provided that such constructing, repairing, altering, or reconstructing of said sewer main shall be accomplished in such a manner that the private improvements existing in this right-of-way shall not be disturbed or destroyed, or in the event they are disturbed or destroyed, they will be replaced in as good a condition as they were immediately before the property was entered upon by the Grantee.

The Grantor shall retain the right to use the surface of said easement, so long as said use does not interfere with the ingress and egress to the lift station or installation and maintenance of the sewer main and so long as no permanent buildings or structures are erected on said easement.

This easement shall be a covenant running with the land and shall be binding on the successors, heirs, and assigns of both parties hereto.
