EASEMENT

Said easement shall include the right of ingress and egress to, upon, and over said land at any and all times, to construct, maintain and operate, repair, and replace said sanitary sewer line provided, however, that the Grantee shall have the right to utilize such additional width as may be necessary temporarily for the placing of excavated materials thereon, and for other construction, maintenance, and repair operations.
