LEGAL DESCRIPTION FOR:

Dike District No. 3

An easement of varying widths being in a portion of the West Half of Section 20, Township 3,3 North, Range 4 East, W.M., lying Westerly and adjoining a portion of the Easterly line of that certain survey as recorded in Book 4 of Surveys at page 84, under Auditor's File No. 8302250026, described as follows:

Beginning at the Northeast corner of said parcel as shown on said survey; thence the following courses, along the East line of said easement, South 0° 39' 38" West, 80.00 feet with a width of 80.00 feet to the West, thence continue with a width of 25.00 feet to the West, South 0° 39' 38" West 401.00 feet; thence South 1° 18' 59" West, 523.67 feet; thence South 32° 08' 28" West, 358.25 feet; thence South 8° 14' 24" West, 409.06 feet; thence South 7° 00' 39" West, 357.61 feet; thence South 0° 27' 15" East, 504.12 feet; thence South 0° 10' 22" East, 316.55 feet to an angle point in said survey; thence leaving the boundary of said survey, South 0° 10' 22" East, 173.60 feet, more or less, to the centerline of an existing gravel driveway and the terminus of this Easterly line description.

Said easement lies westerly of the above-described line and the Westerly line shall be extended or trimmed so as to form a continuous line across the Grantor's ownership.

EXCEPT any portion lying within the right-of-way of Conway Hill Road.
