For the same consideration Grantees hereby assume all obligation of MARY K. STOFFERS under the terms of the instruments creating and securing the loan referred to in the deed of trust, and also agree to indemnify the Department of Veterans Affairs to the extent of any claim payment arising from the guaranty or insurance of the indebtedness above mentioned. Grantees further agree to the release of any or all prior obligors of the indebtedness above mentioned.

Grantee agrees that this Quit Claim Deed will be null and void and invalidated if for any reason the refinancing of above-named property is not completed and/or fails and/or the mortgage filed under Auditor's number 9709240040 with Norwest Mortgage, Loan number 645764, is not paid in full, relieving Grantor of any future financial liability thereunder.
