## EXHIBIT A Released Property

That portion of the Westerly M of the vacated alley lying between Lots 1, 2, 10, 11 and 12, Block M, "MAP OF LACONNER, WHATCOM COUNTY, WASHN. TERRY., 1872", as per plat recorded in Volume 2 of Plats, page 49, records of Skagit County, Washington, lying within the following described tract:

Beginning at the Southwesterly corner of said Lot 1, being the intersection of the East right-of-way of the vacated alley and the Northerly right-of-way of Washington Avenue;

thence North along the East right-of-way line of said alley a

distance of 6.00 feet to the TRUE POINT OF BEGINNING; thence Northwesterly, on a line perpendicular to the North right-of-way line of Washington Avenue, a distance of 28.88 feet to the intersection of a line which is 5.00 feet Westerly of the center

line of said alley; thence North, along a line with is 5.00 feet Westerly of the center line of said alley, a distance of 40.20 feet to an intersection with the Southwesterly extension of the Northwesterly line of said

Lot 2; thence Northeasterly, along said line, to the Northwesterly corner of said Lot 2;

thence Southwesterly, along the Easterly right-of-way line of said alley, to the TRUE POINT OF BEGINNING.
