MODIFICATION OF REAL-ESTATE CONTRACT

For good and valuable consideration, the receipt of which is hereby acknowledged, ERROL HANSON, as the successor in interest to the Seller's interest in that Real Estate Contract dated the 15th day of April, 1986, and recorded in the office of the Skagit County Auditor under Auditor's File No. 8603100081, with respect to the hereinafter described real property, between Margery Swanson, as Seller, and Douglas J. Becktel and Lisa Becktel, as Purchasers, and DOUGLAS J. BECKTEL, as purchaser, hereby agree to modify the Real Estate Contract pursuant to the following terms and conditions:

- 1. The full contract balance as of October 5, 2000, is in the sum of ELEVEN THOUSAND FIVE HUNDRED AND NO/100 (\$11,500.00) DOLLARS;
- 2. The interest rate on the balance due shall remain at TEN (10%) PERCENT PER ANNUM;
- 3. Monthly payments shall be due on or before the 1st day of each month, with the next payment due on or before November 1, 2000;
- 4. The monthly payment of principal and interest shall be increased to the sum of FIVE HUNDRED AND NO/100 (\$500.00) DOLLARS;
- 5. A TWENTY FIVE AND NO/100 (\$25.00) DOLLAR late charge shall be assessed on any payment not received on or before the due date;
- 6. The full balance of principal and interest shall be due on or before November 1, 2003.
- 7. In all other respects, the terms of the said Real Estate Contract shall remain in full force and effect, except as provided herein.
