EASEMENT

For and in consideration of THIRTY THOUSAND AND NO/100 (\$30,000.00) DOLLARS, receipt of which is hereby acknowledged and the future delivery of FOUR THOUSAND (4,000) tons of corn ensilage over a period of THREE (3) consecutive years commencing in 1995 (1,334 Tons per year with an agreed value of \$5.00 per ton), the Grantor, DOUWE DYKSTRA, a single man, hereby conveys, grants and warrants to the Grantee, NATIONAL FROZEN FOODS CORPORATION, the right, privilege and authority to construct, inspect, repair, improve and maintain a 12" waste water pipeline (to be buried to a minimum depth of 42" inches from the top of pipeline) together with the further right to install underground power and water, under, over, through and across the real property described in the following Exhibits "A-I", "A-2" and "A-3", attached hereto and by this reference incorporated herein.

The Grantee shall have the right to enter upon the property following the execution of this Easement to install and construct the foregoing utilities and agrees after construction to return the land to a level suitable for farming, and in the spring of 1996 shall pay the Grantor the sum of TWO HUNDRED AND NO/100 (\$200.00) DOLLARS cash as damages for the repair of said easement.

In the exercise of the rights granted herein, the Grantee, its successors and assigns may pass and repass over said easement for purpose of repairing or maintaining the waste water pipeline, water line or power line.

The benefits and burdens, as well as the rights and obligations of the parties, shall be deemed to run with the land and shall be binding upon all heirs, successors and assigns of the parties hereto.
