Pursuant to the Second Amendment, Term Note I has been renewed by that certain renewal term note I of even date herewith in the principal amount of \$2,072,575.39 ("Renewal Term Note I") executed and delivered by Grantor to Beneficiary, such that all references in the Deed of Trust to "Term Note I" shall constitute references to "Renewal Term Note I." Pursuant to Renewal Term Note I, the interest rate on the loan secured by the Deed of Trust has been reduced.
- 4. Except as specifically provided for herein, all of the terms and conditions of the Deed of Trust shall remain in full force and effect.
