Removal of restriction on manufactured homes per Skagit County Short Plat No. PLOO-00545 recorded under Skagit County Auditor's File No. 200105220102


We the undersigned being legal owners of Lots 1-4 of above Short Plat, hereby remove manufactured home restriction on said lots.

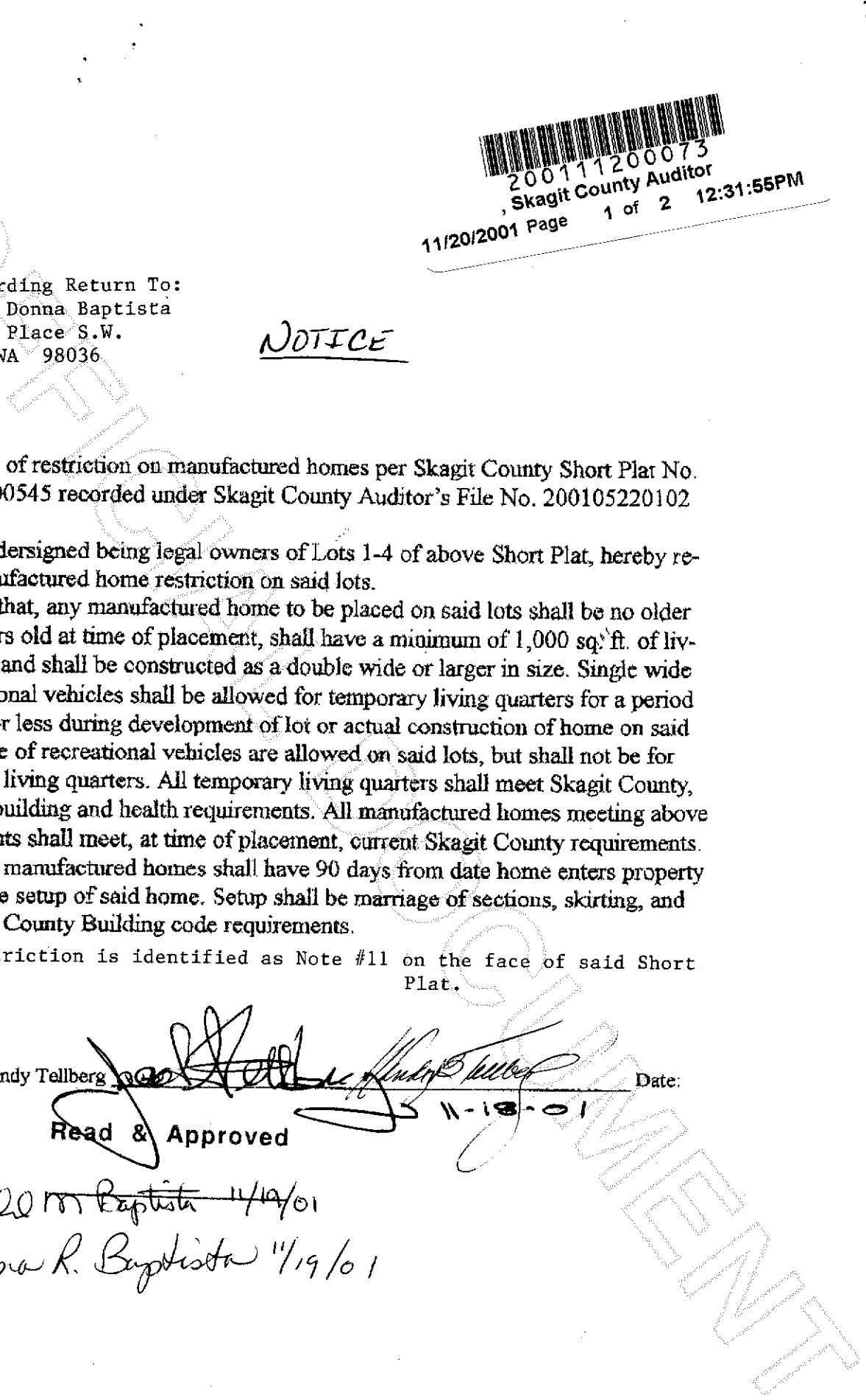
Providing that, any manufactured home to be placed on said lots shall be no older than 2 years old at time of placement, shall have a minimum of 1,000 sq. ft. of living space, and shall be constructed as a double wide or larger in size. Single wide or recreational vehicles shall be allowed for temporary living quarters for a period of 1 year or less during development of lot or actual construction of home on said lot. Storage of recreational vehicles are allowed on said lots, but shall not be for permanent living quarters. All temporary living quarters shall meet Skagit County, planning, building and health requirements. All manufactured homes meeting above requirements shall meet, at time of placement, current Skagit County requirements. Owners of manufactured homes shall have 90 days from date home enters property to complete setup of said home. Setup shall be marriage of sections, skirting, and any Skagit County Building code requirements.

Said Restriction is identified as Note #11 on the face of said Short Plat.
