LETTER OF AGREEMENT

Springwater System No. 1 of Skagitwilde, a Washington Corporation, and Eddie and Betty Lemos agree as follows:

- 1. At the request of Eddie and Betty Lemos, Springwater System No. 1 after February 28, 1998, will cease to be responsible for providing water service to the property of Eddie and Betty Lemos at 4009 South Skagit Highway, Sedro-Woolley, WA. This property encompasses Lots 16 and 17 as shown on the plat of Skagitwilde recorded with Skagit County in Washington State.
- 2. Eddie and Betty Lemos shall cease to be members of Springwater System No. 1 after February 28, 1998, and shall not be responsible for any membership costs or debts incurred by Springwater System No. 1 after that date.
- 3. After February 28, 1998, Springwater System No. 1 shall bear no responsibility nor obligation for providing water to any property owned at Skagitwilde by Eddie and Betty Lemos or by their heirs, assigns or devisees. Springwater System No. 1 has made no representation as to the availability of water from other sources.
- 4. This letter of agreement shall be issued in two copies, one to be signed before a notary public by Eddie and Betty Lemos and the other to be signed before a notary public by the president of Skagitwilde Corp. The two signed, notarized copies shall together form one overall letter of agreement and shall be considered as such and shall be recorded as such in Skagit County, Washington, by Springwater System No. 1. The parties shall exchange copies.

5. This letter memorializes the entire agreement of the parties and, in reliance thereon, each party hereby agrees to release and discharge each other from any liabilities or obligations in connection with Springwater System No. 1 that may arise
after February 28, 1998. The parties further agree to indemnify and hold each harmless from
claims made by third parties arising out of their previous association in Springwater System No. 1.
