Subordination Agreement

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

GERALD HAMBURG AND MARGE A. HAMBURG, HUSBAND AND WIFE AND EUGENE R. MARBLE AND JOAN MARIE MARBLE, HUSBAND AND WIFE AND OLAF A. GILDNESS AND GAYLE GILDNESS, HUSBAND AND WIFE referred to herein as "subordinator", is the owner and holder of a mortgage dated 2-15-02 , which is recorded in volume of Mortgages, page , under auditor's file No. 200203210009 , records of SKAGIT County.

HORIZON BANK referred to herein as "lender", is the owner and 2-15-02 , executed by HANSELL MITZEL L.L.C., DBA MITZEL holder of a mortgage dated HOMES (which is recorded in volume 2002010008 of Mortgages, page under auditor's file No. , records of SKAGIT County) (which is to be recorded concurrently herewith).

HANSELL MITZEL L.L.C., DBA MITZEL HOMES referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
