Beginning at a point 462 feet North and 140 feet East of the West quarter corner of said Section 19; thence East parallel with the Cemetary Road 128 feet; thence South 110 feet; thence West parallel with the Cemetary Road 128 feet; thence North 110 feet to the point of beginning.

TOGETHER WITH a non-exclusive easement for right of way over the East 15 feet of that portion of Government Lot 2, Section 19, Township 35 North, Range 5 East of W.M. described as follows:

Beginning at a point 462 feet North and 140 feet East of the West quarter corner of said Section 19; thence East parallel with

the Cemetary Road 128 feet; thence North 154 feet, more or less, to the Southerly line of the highway which is parallel with the Great Northern Railway Company's right of way; thence Southwesterly along said Southerly line 154.3 feet, more or less, to a point 69 feet North of the point of beginning; thence South 69 feet to the point of beginning.
