PARTIAL RELEASE OF PAY-BACK AGREEMENT

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS; Skagit County Sewer District No. 2, a municipal corporation of the State of Washington, located in Skagit County, Washington (hereinafter called "District") entered into a Pay-Back Agreement (hereinafter called "Agreement") with EDWARD P. WARDELL (hereinafter called "Developer") A/K/A MERIMBULA D/E 00-04, which instrument was recorded December 17, 2001 under Skagit County Auditor's File No. 200112170143, and

WHEREAS; said Agreement disclosed that Developer had constructed and installed 800 feet of sewer main which sewer system was later conveyed to and accepted by the District, and

WHEREAS; said Agreement provided that, for a period of ten (10) years from the date of the Agreement, the District would, upon request of any of the owner's of property described therein to connect to the aforementioned sewer system, collect the connection charge disclosed therein on behalf of the Developer in accordance with the Agreement and reimburse and pay over said amount to the Developer, and

WHEREAS; the above-mentioned P#64415 was included in the Payback in error all amounts due and owing under the Agreement are null and void,

NOW, THEREFORE, the District does hereby release and discharge from the lien of said Agreement the following described property, to wit:

CHEASTY'S BIG LAKE, TRS, TR 25 P64415 AND/OR 3882-000-025-0008

But this release shall not impair the line of the Agreement as to the lands therein described but not released herein.
