Subordination Agreement

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- PEOPLES BANK, referred to herein as "subordinator", is the owner and holder of Deed of Trust dated December 13, 2000, which is recorded under auditor's file No. 200012210026, records of SKAGIT County.
- 2. PEOPLES BANK referred to herein as "lender", is the owner and holder of a Deed of Trust dated May 6, 2002, executed by HANSELL / MITZEL L.L.C. (which is recorded under auditor's file No. 20070533 01/2, records of SKAGIT County) (which is to be recorded concurrently herewith).
