This correction easement is executed on the 15th day of October, 2001.

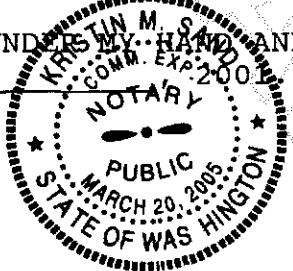
