DESCRIPTION:

PARCEL "A":

That portion of Government Lot 4, Section 1, Township 36 North, Range 3 East, W.M., described as follows:

thence North 20°24'18" West a distance of 228.58 feet; thence North 87°17'28" West a distance of 455.33 feet, more or less, to a point on a line which is 30.00 feet Easterly of and parallel with the Westerly line of Government Lot 4;
