This subordination is limited to the amount actually loaned by the Lender to the Borrower (principal and accrued interest) for the forgoing purposes and also the amount actually advanced for foreclosure costs and other advances made or to be made by the Lender, for a total limitation not to exceed \$200,000.00 .* Any amount which is in excess of this figure will not be covered by this subordination unless prior written consent was obtained from KeyBank of Washington for incurring the expenditure in question. The Lender will incorporate into the borrower's note a statement that the loan will be in default should any proceeds of the loan funds obtained as a result of this subordination be used for a purpose that will contribute to excessive erosion of highly Erodible land or to the conversion of wetlands to produce an agriculture commodity, as explained in Exhibit M of Subpart G of Part 1940 of Title 7 of the Code of Federal Regulation.
