QUIT CLAIM DEED

For and in consideration of the clearing of title to correct a surveyor's error, grantor does hereby QUIT CLAIM to the grantee all of her interest in the following real property lying and being in the county of Skagit and State of Washington, and described as follows, to wit:

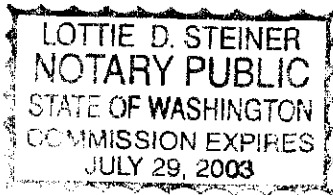
