

effective immediately.



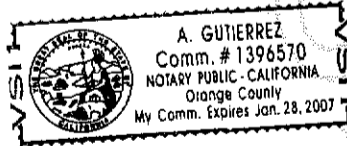
