THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE REAL PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

THIS SUBORDINATION AGREEMENT is made and entered into as of September 30, 2003, by and between Whidbey Island Bank, a corporation ("Whidbey Island"), Woodsdale LLC, a limited liability company ("Woodsdale"), and Spring Meadows, LLC, a limited liability company ("Spring Meadows").

- C. Whidbey Island will become the beneficiary under a Deed of Trust dated September ______, 2003, executed by Woodsdale, which is to be recorded concurrently herewith ("Whidbey Island's Deed of Trust") under Auditor's File No. _______ (the superior deed of trust).

AGREEMENTS

- Spring Meadows acknowledges that, prior to the execution hereof, Spring Meadows has had the opportunity to examine the terms of Whidbey Island's Deed of Trust and agreements relating thereto, consents to and approves the same, and recognizes that Whidbey Island has no obligation to Spring Meadows to advance any funds under Whidbey Island's Deed of Trust, and any application or use of such funds for purposes other than those provided for in Whidbey Island's Deed of Trust or agreements relating thereto shall not defeat the subordination and encumbrance herein made in whole or in part.
- 3. It is understood by the parties hereto that **Whidbey Island** would not make the loan secured by **Whidbey Island's** Deed of Trust without this Subordination Agreement.
- 4. Whidbey Island agrees to provide Spring Meadows with reasonable notice and a reasonable opportunity to cure in the event of any default by Woodsdale under Whidbey Island's Deed of Trust and all agreements in connection therewith.
