SUBORDINATION AGREEMENT

This Subordination Agreement (this "Agreement"), granted this <u>2nd</u> day of <u>December, 2003</u>, by Advanta National Bank ("Chase") to <u>Chase Manhattan Mortgage</u> <u>Corporation</u> (the "Lender"),

WITNESSETH:

WHEREAS, Chase has heretofore extended a line of credit/loan to Michael J. and Margaret E. Bartee (the "Borrower") pursuant to a Home Equity Line of Credit Agreement/Loan Note dated September 22, 2000 (the "Line of Credit/Loan"); and

WHEREAS, the Borrower's obligations under the Line of Credit/Loan #16440174 are secured by a Deed of Trust from the Borrower to trustees for the benefit of Chase named therein, dated September 22, 2000, recorded in the Land Records of Skagit County, Washington in Auditor's No. 200009270062 (the "Home Equity Deed of Trust") covering real property located at 500 N. Barker St., Mt. Vernon, WA 98273 (the "Property"); and

WHEREAS, the Lender proposes to make a loan in the original principal amount of \$134,066.00 to the Borrower (the "New Loan"), the proceeds of which will be used to repay in full all of the Borrower's original obligations secured by an original Deed of Trust, and to obtain a release of the lien created by the original Deed of Trust; and *recorded under Auditor's File No. 200308050302 records of Skagit County, WA,

WHEREAS, as a condition of making the New Loan, the Lender has required the Borrower to execute a deed of trust on the Property securing repayment of the New Loan (the "New Deed of Trust"), which, upon execution and recordation of this Agreement, shall have a first lien position on the Property.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Chase hereby agrees as follows:

- 1. Chase hereby subordinates the lien created by the Home Equity Deed of Trust to the lien created by the New Deed of Trust to the end that the lien of the New Deed of Trust shall be superior to the lien of the Home Equity Deed of Trust.
- The subordination described in paragraph 1. above shall not apply
 to any future advance of funds to the Borrower by the Lender except for advances
 necessary to protect the security of the New Deed of Trust.

- This Agreement shall be binding upon and shall inure to the benefit 3. of Chase and the Lender and their respective successors and assigns, and any purchaser at any foreclosure sale instituted pursuant to the Home Equity Deed of Trust or the New Deed of Trust.
- This Agreement shall be construed in accordance with the laws of the State of Washington.




