

**LEGAL DESCRIPTION**

The South 1/2 of the West 1/2 of Tract 36, and that portion of the North 1/2 of the West 1/2 of Tract 37, "PLAT OF THE BURLINGTON ACREAGE PROPERTY," as per plat recorded in Volume 1 of Plats, page 49, records of Skagit County, Washington, and vacated portion of the platted road vacated by Commissioners File No. 11597, all of which is more particularly described as follows:
