Expenses of the mediation including the mediator's fees shall be shared equally between Lender and

### (C)Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding SIX and 15/100 percentage points (6.150 %) to the Current Index. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.
