## ADDENDUM TO SEPARATION CONTRACT

The relevant provision of the original contract with respect to spousal maintenance reads as follows:

## 6. Provisions for Maintenance.

As maintenance, the parties agree as follows:

Commencing in May 2003, DONALD L. BAKKEN will pay to A. BETTY J. BAKKEN the sum of \$1650.00 (sixteen hundred and fifty dollars) per month, through the month of August, 2004. After the month of August, 2004 the amount will be reduced to \$1410.00 (fourteen hundred and ten dollars) per month.

By agreement of the parties, the provision above is modified as follows:

## 6. Provisions for Maintenance.

As maintenance, the parties agree as follows:

Commencing in May 2003, DONALD L. BAKKEN will pay to A. BETTY J. BAKKEN the sum of \$1650.00 (sixteen hundred and fifty dollars) per month, through the month of August, 2004. After the month of August, 2004 the amount will be reduced to \$1500.00 (fifteen hundred dollars) per month.
