II. ORDER

THIS MATTER, having come on regularly before the above-entitled Court, the undersigned Judge/Court Commissioner presiding, upon the motion of the Respondent, Eugenia Sullivan, and the Court being otherwise fully advised in the premises, NOW, THEREFORE, IT IS HEREBY

ORDERED, ADJUDGED AND DECREED that the court finds the Petitioner, Edward Sullivan, has failed to comply with the parties' Decree of Dissolution entered on December 6, 1984 by failing to pay court ordered maintenance and/or one-half of his pension to the Respondent as ordered. Respondent shall have a judgment against the Petitioner for unpaid maintenance (the difference between \$875 per month and what Petitioner actually paid) from 1995 to present in the amount of \$56,833.90. Said judgment does not include unpaid "cost of the living" increases or interest on cost of living increases that should have been paid. A separate judgment for said amount shall be entered at a later date and may be entered Ex Parte upon 5 days written notice to Petitioner. The Petitioner shall provide documentation to Respondent as to the exact amounts he has received as pension payments (either monthly or annually) since January, 1995 to allow Respondent to determine what the cost of living increases have been since 1995. Said documentation shall be produced within one week (7 days) of the date of this order. The Petitioner shall be assessed \$100.00 per day penalty for every day he is past due (beginning June 3, 2003) if he fails to produce said pension and/or cost of living information. Said amount shall be set forth as a judgment

1 against the Petitioner in favor of the Respondent and may be entered Ex Parte upon 5 days
2 written notice to Petitioner; and NOW, THEREFORE, IT IS HEREBY

3 ORDERED, ADJUDGED AND DECREED the QDRO submitted herein by separate
4 order shall be signed and approved. Said QDRO awards 60% to the Respondent as partial
5 payment toward the judgment set forth herein. If the QDRO must be revised pursuant to the
6 Plan Administrator's direction, and the Petitioner refuses to sign the amended QDRO or
7 cooperate, then Catherine del Fierro shall be appointed as Commissioner in Fact under CR 70
8 to sign in Petitioner's stead; and NOW, THEREFORE, IT IS HEREBY *

10 ORDERED, ADJUDGED AND DECREED that the Petitioner shall provide
11 verification of life insurance policies held in 14c, j, k and 15 of the Decree within fifteen (15)
12 days of entry of this Order. Said verifications shall date back to 1985 to present. If the
13 Petitioner does not provide verification, he shall be fined \$50 per day for every day he has not
14 provided verification; and NOW, THEREFORE, IT IS HEREBY

16 ORDERED, ADJUDGED AND DECREED that Respondent shall have a judgment
17 against the Petitioner for attorneys for \$2,500 for having filed said motion. Said attorney's
18 fees shall be paid within ten (10) of entry of this order. *
