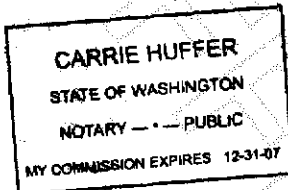

EXCEPTIONS:

- A. Exceptions and reservation contained in deed from Wm. Lindsay et ux, recorded August 22, 1905 in Volume 59 of Deeds, page 183, as follows:

"Excepting and reserving from this conveyance all petroleum, gas, coal, and other minerals with the right of entry to take and remove the same."

- B. Restriction contained in instrument recorded December 14, 1912 under Auditor's File No. 94380, as follows:

"...that no saloon shall ever be located or established upon the lands herein described..."

- C. Notes contained on the face of Short Plat No. 29-88, as follows:

1. All maintenance and construction of private roads are the responsibility of the lot owners and the responsibility of maintenance shall be in direct relationship to usage of road;
2. Short Plat number and date of approval shall be included in all deeds and contracts;
3. Sewage Disposal - Individual Septic System (See Note #7);
4. Water - Well (See Skagit County Board of Health Res. No. 11485);
5. Alternate on site sewage disposal system may have special design, construction and maintenance requirements. See Skagit County Health Officer for details;
6. Road right-of-ways for SR 9 and SR 538 have been calculated by locating the as built road and fitting its location to existing road maps of the area. The following maps were obtained from State and County sources: "County Road Big Lake Northwest 1/4 12-13-35 (State); "Secondary State Highway No. 1-G PSH No. 1 to Big Rock" June 1952 (State); SR 538 Right of Way Plan" April 28, 1972 (State) and "Skagit County Local Improvement District No. 9", June 1919 (County). These maps are not consistent with each other and ties between the highways are poor. The Washington State D.O.T. is currently working in this area, specifically the Big Rock intersection, the results of their finding are not available at the time of recording of the Short Plat. See the Washington State D.O.T. for any possible changes in right of way configuration of this area.
