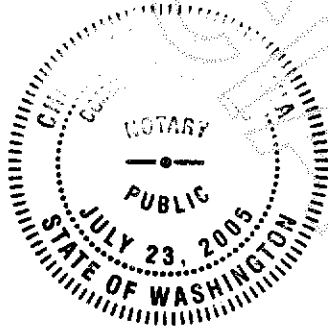

That portion of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of Section 24 Township 35 North, Range 4 east, W.M., described as follows:

Beginning at a point of the East line of the said Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$, being 618 feet North of the Southeast corner thereof, said point also being the Northeast corner of a tract conveyed to L. L. Merrill by deed recorded May 25th, 1909 in Volume 77 of Deeds, page 284, records of Skagit County, Washington, under File No. 73841; thence West along the North line of the said Merrill tract a distance of 218 feet, more or less, to the Northeast corner of a tract conveyed to Jennie Voigt by deed recorded July 9th, 1907 in Volume 69 of Deeds, page 617, records of Skagit County, Washington, under Auditor's File No. 63040, said point also being the Northwest corner of the said Merrill tract; thence continuing West along the North line of the said Voigt tract a distance of 218 feet, more or less, to the Northeast corner of a tract conveyed to Joseph Doucette by deed recorded November 16th, 1906 in Volume 67 of Deeds, page 514, records of Skagit County, Washington, under File No. 59625, said point also being the Northwest corner of the said Voigt tract; thence Northerly along the Northerly extension of the Westerly line of said Voigt tract (being also the Northerly extension of the Easterly line of the said Doucette tract) to the North line of the Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the said Section 24; thence Easterly along the North line of the said Southeast $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ of the Southwest $\frac{1}{4}$ to the Northeast corner thereof; thence South along the East line thereof to the point of beginning.
