SPECIAL WARRANTY DEED

THE GRANTOR, WELLS FARGO BANK, N.A., Successor by Merger to Pacific Northwest Bank, formerly known as Interwest Bank, in consideration of Ten Dollars (\$10.00), in hand paid, and for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, grants, bargains, sells, conveys and confirms to COMMERCIAL HOLDINGS LLC, a Washington limited liability company ("Grantee") the real estate situated in the County of Skagit, State of Washington, and legally described on Exhibit A attached hereto and by this reference made a part hereof (the "Property").

The Grantor for itself and its successors in interest does by these presents expressly limit the covenants of the deed to those herein expressed, and excludes all covenants arising or to arise by statutory or other implication, and does hereby covenant that against all persons whomsoever lawfully claiming or to claim by, through or under said Grantor and not otherwise, will forever warrant and defend the said described real estate. Additionally, this conveyance is made subject to the restriction that prior to March 1, 2005, (i) no bank, credit union, savings and loan or other financial institution shall operate in all or any part of the Property, (ii) Grantee shall occupy the Property solely for purposes of demolition, construction or reconstruction and remodeling of the improvements thereon, except that after the expiration of thirty (30) days after the date this Special Warranty Deed is recorded in the real property records of Skagit County, Washington, the Property may be occupied by any tenant that is not a bank, credit union, savings and loan or other financial institution; and (iii) Grantee shall not erect, display or permit on or about the Property, any advertisement, signage or other identification of whatever kind or nature concerning the ownership by, or operation of the Property for purposes of a bank, credit union, savings and loan or other financial institution. As used herein, the terms "bank, credit union, savings and loan or other financial institution" shall mean and refer to any entity having a state or federal charter to act as a financial institution of any kind (including, without limitation, as a mutual or federal savings bank), any mortgage company or any other entity that accepts deposits, issues certificates of deposit, makes secured or unsecured loans or engages in other, similar financial transactions in the ordinary course of its business. The foregoing restriction shall run with the Property and be binding on Grantee and its successors and assigns.
