# CITY OF ANACORTES AND RADIUS ANACORTES PROPERTIES, LLC (ANACORTES CINEMA)

#### RECITALS

The City of Anacortes (Lessor) and Radius Anacortes Properties L.L.C. (Lessee) desire to strengthen their direct relationship and restructure the Rent Payment Schedule.

#### **AGREEMENT**

Section 4 is replaced in its entirety with the following:

#### 4. Rent:

- a. October 1, 2001 through September 30, 2005: Lease rent will be changed retroactively to \$800 p/month. WA State Leasehold Tax will be based on \$1,000 p/month lease rent or \$128.40 p/month through September 30, 2005.
- b. October 1, 2005 through September 30, 2009: Lease rent twill be \$1,000 p/month and WA State Leasehold Tax will be \$128.40 p/month or at whatever is the current legal rate.
- c. October 1, 2009 though September 30, 2013: Lease rent will be \$1, 200 p/month and WA State Leasehold Tax will be at whatever is the current legal rate.
- d. Thereafter, the rent shall be adjusted on April 1, 2013, 2017, 2021, and 2025 based on the percentage of change in the Consumer Price Index All Urban Consumers (Seattle-Tacoma-Bremerton); to avoid using preliminary figures, the adjustment shall be based on the change from June the preceding year to the June four (4) years before.
- e. In no event shall the rent increase by more than 10% at each adjustment during the initial 25-year term.
- f. The City will waive all Late Fees accrued before September 30, 2005.
- g. The City will impose a \$100 Late Fee on all monthly payments not made within 15 days after the due date, which is the first of each month.
- h. The City will forgive all outstanding balances, if any, as of September 30, 2005.
