Tract B of Survey recorded December 31, 2002 under Auditor's File No. 200212310308, records of Skagit County, Washington, being a portion of Lots 1 through 7, inclusive, Block 4, PLAT OF HAMSTROM'S ADDITION TO GRASSMERE, according to the plat thereof recorded in Volume 3 of Plats, page 82, records of Skagit County, Washington; as recorded in Quit Claim Deed for Boundary Line Adjustment under Auditor's File No. 200212020282, records of Skagit County, Washington; more particularly described as follows:

Commencing at the Southeast corner of Lot 7, Block 4, PLAT OF HAMSTROM'S ADDITION TO GRASSMERE; thence North 00°01′55″ East along the West line of First Street as shown on said plat, for a distance of 120.98 feet to

the true point of beginning;

thence continuing North 00°1'55" East along the West line of First Street as shown on said plat, for a distance of 107.24 feet:
