This deed is for the purpose of securing performance of the agreement of Grantor herein contained, and payment of the sum of (\$64,890.00) SIXTY FOUR THOUSAND EIGHT HUNDRED NINETY AND 00/100 with interest, in accordance with the terms of a promissory note of even date herewith, payable to Beneficiary of order, and made by Grantor, and all renewals, modifications and extensions thereof, and also such further sums as may be advanced or loaned by Beneficiary to Grantor, or any of their successors or assigns, together with interest thereon at such rate as stated in the promissory note.

To Protect the security of this Deed of Trust, Grantor covenants and agrees:

1. - 1. In the event any portion of the property is taken or damaged in an eminent domain proceeding, the entire amount of the award or such portion of it as may be necessary to fully satisfy the obligation secured hereby, shall be paid to the Beneficiary and applied to said obligation, once superior liens have been satisfied.
- 2. By accepting payment of any sum secured hereby after its due date, Beneficiary does not waive its right to require prompt payment when due of all other sums so secured or to declare default for failure to so pay.
- 3. The Trustee shall reconvey all or any part of the property covered by this Deed of Trust to the person entitled thereto on written request of the Grantor and the Beneficiary, or upon satisfaction of the obligation secured with written request for reconveyance made by the Beneficiary or the person entitled thereto.
- 4. Upon default by Grantor in the payment of any indebtedness secured hereby or in the performance of any agreement contained herein, all sums secured hereby shall immediately become due and payable at the option of the Beneficiary.
