The term "Property" in this subordination refers to the following described real estate ONLY: Lot 15 of the Plat of Sauk Mountain View Estates South, A Planned Residential Development Phase 3, according to the Plat thereof, as recorded May 26, 2005, under Auditor's File No. 200505260107, records of Skagit County, Washington, Situate in Skagit County, Washington
- 4.
