

- The odd shape of the lots and multiple access points makes it difficult to determine the front, back and the sides of the lots. We asked the City of Mount Vernon what the City would determine to be the front, back and sides. The City refused to gives us an opinion. The City is the entity that dictates the set back lines. We do not show the building setback lines because we would have to guess which lines the City would call the front, back and sides. The City did say the front setbacks are 25 feet and the side and back do not have a setback.

BOUNDARY ENCROACHMENTS:

- NOTE: The boundary of this parcel is surrounded on most sides by parking lots and planter strips. Parking lot accesses, planter strips and sidewalks cross the property lines at multiple locations. It is not possible to distinguish who owns these improvements, therefore, this survey does not label these improvements as enchroachments. This survey shows the location of the improvements and the property lines, but this survey does not define if the improvements are encroachments.
- The fire hydrant on the most Easterly edge of Lot 1 is 8 feet on the property and appears to be an enchroachment.
