which Real Property is partially platted and the portion platted is recorded as Skagit Highlands Divisions 1-4. The Quadrant Corporation, a Washington corporation, is the successor in interest to Declarant in portions of the Real Property, and joins in the execution of this Amendment. Capitalized terms in this document shall have the meaning assigned to them in the Covenant.

- 2. <u>Reservation of Right to Amend Covenant</u>. Under Article V, Section 5.6 of the Covenant, Declarant reserves the right to amend the Covenant to comply with the requirements of the Local Jurisdiction regarding the Real Property and the Master Plan. The requirements of the Local Jurisdiction related to the Modified Collector Arterial are a condition of the Master Plan and the subdivision of the Plat, and are the proper subject of a unilateral amendment of the Covenant by the Declarant and the Declarant's assignee.
- 3. <u>Purpose of Amendment</u>. The purpose of this Amendment is to add a descriptions of the duties owed by the Residential Association related to the Modified Collector Arterial.

B. AMENDMENT OF THE DECLARATION AND COVENANT TO ADD ADDITIONAL COMMUNITY AREA RESPONSIBILITY

Amendment to Article IV, to add new Section 4.4. Section 4.4 is added to Article IV:

Until such time as the Modified Collector Arterial is owned and maintained by the City of Mount Vernon (the Local Jurisdiction), the Residential Association shall adopt such rules, enforceable against the Members of the Association, as are needed to require that the Modified Collector Arterial remains clear of obstructions which may restrict fire and emergency vehicle access. The Residential Association shall engage in such actions as are reasonably needed to enforce the rules adopted, and keep the Modified Collector Arterial free of obstructions, consistent with the requirements of the Local Jurisdiction.

C. COMMUNITY AREA RESPONSIBILITIES FOR MODIFIED COLLECTOR ARTERIAL CONFIRMED AND ACCEPTED BY RESIDENTIAL ASSOCIATION

The Residential Association shall henceforth administer enforcement of restrictions upon the obstruction of the Modified Collector Arterial, located in Skagit Highlands in the manner provided herein, and as further directed by the Local Jurisdiction.
