RESTRICTIVE COVENANT

The grantor herein, WINBLAD FAMILY TRUST, GORDON STANLEY WINBLAD & DEBRA BARTHENA WINBLAD, TRUSTEES, are the owners of (an interest in) the following described real estate situated in Skagit County, State of Washington:

Lot 10 (P119389) of Elk Haven Estates as recorded in Auditor File No. 200208060083 as shown on the face of the recorded plat with A Well Protection Zone Easement for Lot 9 & 10 of Elk Haven Estates.

The grantee herein, LONGNECKER FAMILY REV TRUST, DAVID K. LONGNECKER & MARGARET N. LONGNECKER, TRUSTEES own and operate a well and waterworks supplying water for public use, located upon the following described real estate situated in Skagit County, State of Washington:

Lot 9 (P119388) of Elk Haven Estates as recorded in Auditor File No. 200208060083 as shown on the face of the recorded plat with A Well Protection Zone Easement for Lot 9 & 10 of Elk Haven Estates.

Said well and waterworks is in close proximity to the land of the grantor, and said grantee is required to keep the water supplied from said well free from impurities which might be injurious to the public health.

It is the purpose of these grants and covenants to prevent certain practices hereinafter enumerated in the use of the said grantor land which might contaminate said water supply.

NOW, THEREFORE, the grantor agrees and covenants that said grantees, its successors and assigns said covenants to run with the land for the benefit of the land of the grantees, that said grantor's (their) heirs, successors and assigns will not construct, maintain, or suffer to be constructed or maintained upon the said land of the grantor and within 100 (One Hundred) feet of the well herein described, so long as the same is operated to furnish water for public consumption, any potential source of contamination, such as septic tanks and drainfields, sewerlines, underground storage tanks, roads, railroad tracks, vehicles, structures, barns, feed stations, grazing animals, enclosures for maintaining fowl or animal manure, liquid or dry chemical storage, herbicides, insecticides, hazardous waste, or garbage of any kind or description.

These covenants shall run with the land and shall be binding to all parties having or acquiring any right, title, or interest in the land described herein or any part thereof, and shall inure to the benefit of each owner thereof.
