- This conveyance is made pursuant to the powers, including the power of sale, conferred upon the Trustee by that certain Deed of Trust between Sound Property Solutions, Inc., as grantor, to First American Title Insurance Company as trustee, and Robert J. Withers and Jeanne Withers, Co-Trustees of the Withers Family Trust under agreement dated September 27, 1995, as beneficiary, dated October 11, 2006, and recorded October 20, 2006, under Auditor's File No. 200610200158, records of Skagit County, Washington. - 5. Robert J. Withers and Jeanne Withers, being then the holder of the indebtedness secured by the Deed of Trust, delivered to the Trustee a request directing the Trustee to sell the Property in accordance with the law and the terms of the Deed of Trust.

The default specified in the Notice of Default not having been cured, the Trustee, in compliance with the terms of the Deed of Trust, executed and on December 14, 2007, recorded in the office of the Auditor of Skagit County, Washington, a Notice of Trustee's Sale of the Property under Auditor's File No. 200712140099.
- 7. The Trustee, in the Notice of Trustee's Sale, fixed the place of sale as Skagit County Courthouse, a public place at 205 West Kincaid Street, in the City of Mt. Vernon, Washington on March 14, 2008, and, in accordance with the law, caused
