MEMORANDUM OF EXTENSION AGREEMENT

Dated April 7, 2008

WHEREAS CLEAR VALLEY ENVIRONMENTAL FARM, LLC, a Washington limited liability company, as to an undivided 52.5% interest; and CLEAR VALLEY ENVIRONMENTAL FARM II, INC., a Washington corporation, as to an undivided 47.5% interest, as Trustor(s), did make, execute and deliver, a Deed of Trust to LAND TITLE COMPANY OF SKAGIT COUNTY, as Trustee, and OWENS MORTGAGE INVESTMENT FUND, a California limited partnership, as Beneficiary, dated April 10, 2006 and recorded April 27, 2006, at Instrument #200604270155, Official Records of the County of Skagit, State of Washington, given to secure payment of a certain note of same date, in the principal amount of \$3,500,000,00.

NOW THEREFORE, notice is hereby given by the undersigned Trustor(s) and present Beneficiary(s) under the Deed of Trust, pursuant to the terms of said Deed of Trust, that the terms of the obligation evidenced by said Note secured by said Deed of Trust are amended and modified between them to provide that the maturity date has been changed.
