Additional Advance Agreement

The undersigned Pasquale J. Senatore, Jr., a single man, hereinafter "Borrower" or "Senatore" is indebted to Pension Portfolio Services, Inc., a Washington Corporation, hereinafter referred to as "Lender" by a note which is dated February 14, 2006.

ACCOMMODATION RECORDING ONLY

Whereas, said indebtedness is secured by a Deed of Trust dated the same date as the note and recorded August 18, 2006 as Skagit County Auditor's File No. 200608180012 and rerecorded on January 22, 2007 as Skagit County Auditor's File No. 200701220134 and modified by a document recorded April 16, 2007 as Skagit County Auditor's File No. 200704160162, upon property described as follows:

Lots 17 and 18, "VALLEY VIEW ADDITION" in the Southwest ¼ of Section 13, Township 34 North, Range 3 East, W.M. as per plat recorded in Volume 7 of Plats, Page 27, records of Skagit County, Washington. P-70122

Whereas, payments of said loan are current or all payments due under said loan have been paid to date,

Whereas, Borrower has made a request for an advance from Lender for certain improvement costs to the above described property as secured by the above described documents.

## Now therefore for value received, it is agreed:

- Lender will advance the sum of \$15,000.00 for said costs.
- Senatore agrees to the deduction of the charge of \$162 for a to Guardian Northwest Title Company for an Additional Advance Endorsement insuring the Lender and for the deduction of such additional costs as Guardian Northwest Title Company may make for the facilitation of the closing of this advance and distribution of the monies for said development purposes and for any necessary recording costs.
- Monthly payments will be adjusted per month beginning with the next payment due so that loan amortizes in the same time period as previously paid under said loan and said new monthly payment will be calculated by Trust Accounting Center in Anacortes, Washington, where the herein described loan is collected and accounted
- The net funds due Senatore shall be released to him upon his execution of this Agreement.
- And, that except as specifically modified herein, no other term or condition of said note, other addenda or prior documents securing said note are modified and that the other terms and conditions of said referenced documents are unaffected by this extension.
