**Addendum to Option to Buy Real Estate**


This addendum is in reference to the option to purchase for property located at 17346 Bear Creek Road, Bellingham, WA 98229 (P47538).

There shall be no additional changes to the original contracts. All remaining terms and conditions apply.



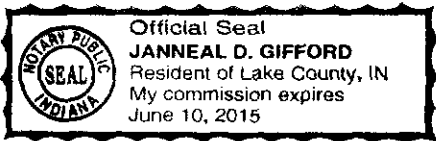

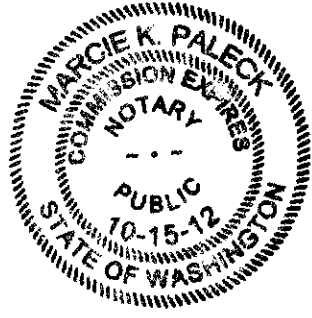
