

Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's sale.

The Trustee makes no representations or warranties concerning what interest in the real property described above is being sold. The Deed of Trust lien being foreclosed may not be a first lien position, or there may be other prior encumbrances of title. The Trustee is not required to provide title information concerning this Property.
