SUBORDINATION AGREEMENT

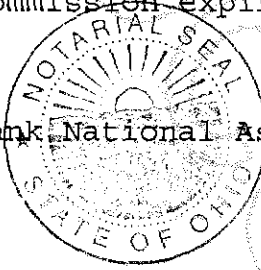
