
QUIT CLAIM DEED

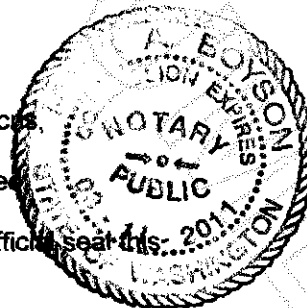


