The GRANTOR, FP TRUSTEE SERVICES, INC., as successor Trustee under that Deed of Trust, as hereinafter particularly described, in consideration of the premises and payment recited below, hereby grants and conveys, without warranty, to WINDWOOD DEVELOPMENT LLC, as GRANTEE, that real and personal property, situated in the County of Skagit, State of Washington, described as follows:

according to the terms thereof, in favor of COLUMBIA STATE BANK, and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.

- 3. The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
- 4. Default having occurred in the obligations secured and/or covenants of the Grantor as set forth in the "Notice of Trustee's Sale" described below, which by the terms of the Deed of Trust made operative the power to sell, the 30-day advance "Notice of Default" was transmitted to the Grantor, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

The Trustee, in its aforesaid "Notice of Trustee's Sale," fixed the place of sale as the main entrance to the Skagit County Courthouse located at 3<sup>rd</sup> and Kincaid Street, City of Mount Vernon, State of Washington, a public place, at 10:00 o'clock a.m., and in accordance with the law, caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by first class and by certified or registered mail, postage prepaid, to all persons entitled thereto and either posted or served a copy of said Notice prior to 90 days before the sale; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the 35th and 28th day before the date of sale, and once between the 14th and seventh day before the date of sale in a legal newspaper in each county in which the property or any part thereof is situated, and further, included with this Notice, which was transmitted or served to or upon the Grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form, to which copies of the Grantor's Note and Deed of Trust were attached.
