## QUIT CLAIM DEED DESCRIPTION FOR JAMIE AND MICHAEL LLOYD

That portion of Government Lot 2 in Section 13, Township 34 North, Range 3 East, W.M., lying Easterly of the following described PARCEL "A", lying Southerly of the following described PARCEL "B", lying Westerly of the West bank of the Skagit River and lying Northerly of Lot 2 of Short Plat No. 90-57, approved March 6, 1991, and recorded in Book 9 of Short Plats, page 325, under Auditor's File No. 9103070022, records of Skagit County, Washington, EXCEPT Dike District No. 12 right of way through the Easterly part of said portion.

## PARCEL "A":

Beginning at a point 540 feet South of the Northwest corner of said Section 13; thence East, 412.5 feet; thence South, 100 feet; thence West, 412.5 feet; thence North to the point of Beginning, EXCEPT county road along the West line thereof.

## PARCEL "B":
